EXECUTIVE SUMMARY

During October and November 2021, the PACE Climate Survey for Community Colleges (PACE) was administered to 413 employees at Northeast Lakeview College (NLC). Of those 413 employees, 139 (33.7%) completed and returned the instrument for analysis. Respondents were also given the opportunity to complete a qualitative section asking what they find most favorable and least favorable about their institution. Of the 139 NLC employees who completed the PACE survey, 77 (55.4%) provided written comments.

Employees completed a 46-item PACE instrument organized into four climate factors as follows: Institutional Structure, Student Focus, Supervisory Relationships, and Teamwork. They also completed a custom section specifically for Alamo Colleges District, Change Readiness Question Set, a Racial Diversity Question Set, and a qualitative section. Respondents were asked to rate the items about the four climate factors on a five-point Likert-type scale ranging from a low of "1" to a high of "5." The PACE instrument administered at NLC included 89 total items and four qualitative questions.

At NLC, the PACE results yielded an overall 4.028 mean score. When disaggregated by the custom personnel classification demographic category of the PACE instrument, Adjunct/CE Faculty rated the campus climate the highest with a mean score of 4.271, followed by Full time Staff (4.077), Part time Staff (4.006), and Full time Faculty (3.930). The Administrator and Work Study means were redacted for confidentiality. The greatest number of favorable comments fell within the Institutional Structure climate factor and the greatest number of unfavorable comments fell within the Institutional Structure climate factor.

Of the 46 standard PACE questions, NLC's top 10 mean scores have been identified as points of pride at NLC. Six pertain to the Student Focus climate factor, two pertain to the Supervisory Relationships climate factor, and two pertain to the Teamwork climate factor.

- The extent to which a spirit of cooperation exists in my department, 4.231 (#43)

Of the 46 standard PACE questions, the bottom 10 mean scores have been identified as areas potentially in need of improvement at NLC. All ten pertain to the Institutional Structure climate factor.
