#### **2020 Census Operational Updates**

# July 31<sup>st</sup> deadline postponed two weeks

- Send notices to your employees and email lists to encourage response. Leverage
  collaboration platforms, employee resource groups, text messages, and customer
  bills and receipts.
- Host a webinar or teleconference to share census information and answer questions.
- Write letters to the editor or op-eds on why census participation is important, particularly to support challenges like the coronavirus (COVID-19).
- Provide free advertising opportunities to promote the 2020 Census.

#### **Online Scams**

We want to remind you to remain vigilant, as phishing attempts are on the rise. Recently, we have seen a spike in coronavirus-related scams.

What You Should Be Looking Out For:

Scammers impersonating organizations such as the World Health Organization (WHO) and providing purported tips, safety measures, and updates on the outbreak. They are leveraging:

- Emails
- SMS messages
- Phone calls

Note: According to the WHO, the organization will never ask users to log in to verify safety information, send unsolicited email attachments, visit a link outside of www[.]who[.]int, or request donations related to emergency response plans.

Governor Abbott Announces Federal Grant for Senior Citizen Meals

AUSTIN - Governor Greg Abbott today announced that Texas has received a \$16.2 million grant from the Department of Health and Human Services' (HHS) Administration for Community Living (ACL) to help communities provide meals for older adults.

Coronavirus Response Act, signed into law by President Trump on March 18, 2020. Originally created by the Older Americans Act (OAA) of 1965, these programs provide meals to more than 2.4 million older adults nationwide each year, both through home delivery and in places like community centers.

"This grant is especially timely given the disproportionately high toll that COVID-19 has been taking on seniors around the world," said Governor Abbott. "As social distancing measures increasingly and appropriately limit people's social mobility, it is imperative that alternate means for feeding our state's elderly like Meals on Wheels receive additional resources to handle the growing need."

Texas will receive its proportional grant, \$16,205,796, second only to California (\$25 million) and Florida (\$18 million) this week for further distribution to local meal providers.
