



NOTICE TO PROGRAM APPLICANTS

The Health Sciences Department makes every effort to provide an understandable application process by insuring each applicant has the necessary information for application completion. It is the student's responsibility to review the application requirements and selection criteria for the individual program to which they are applying as some programs have additional requirements beyond those listed as for the Health Sciences Department. Application requirements and selection criteria are subject to change. Please visit each program's website for detailed information about their program's application and selection process.

All applicants have equal opportunity to contact the program director prior to submitting their application. Each program reserves the right to consider an applicant ineligible for program admission if he/she neglects any part of the stated requirements for application or selection. Fulfilling all application criteria does not guarantee acceptance into a program as program size is limited. Acceptance to any Health Sciences Department Program is subject to completion of a background check and drug screen.

Health Sciences Department front office personnel are able to assist you with general application questions you may have. However, it remains the responsibility of the applicant to follow all written instructions for application submission and selection criteria.

Alamo Colleges District, St. Philip's College, the Health Sciences Department and its programs are not responsible for any applicant misinterpretation of the application or selection process. As evidence that you have read and understand this notice, you will be asked to confirm with your signature on the Health Sciences Department Application.



Application Process

A program application (*separate from the admission application to the College*) must be submitted **no later than August 1st for Fall cohort admission**. Cohorts begin in the fallsemester. To request an application, students must:

- Ensure *ALL college transcripts* be on file in Records and Registration
- Students electing specialization in the Health Information Technology (HIT) program must first meet previously noted St. Philip's College admission requirements
- Students must also meet the HIT Program admission requirements
- Submit an email to the **Program Director** upon completion of all admission requirements and request the HIT Program application. Email must include student Banner ID which is obtained through completion of Alamo Enroll or being currently active as an Alamo Colleges student.

Program Director and/or faculty will review the academic file and respond to the student with information regarding the curriculum and other processes as well as the application if the above listed requirements are met.

PROGRAM INFORMATION

In accordance with the mission of St. Philip's College, the mission of Health Information Technology (HIT) is to provide an environment fostering excellence in technical achievement while remaining responsive to the needs of the community. The mission is fulfilled by providing education and training that assures demonstration of health information entry level competencies by the graduates of the Health Information Technology program.

[Entire HITT curricula is taught online with two exceptions. The first exception is each Fall and Spring semester. HIT students have an orientation day on the first Wednesday of the semester. Secondly, students enrolled in HITT 2361 will need to complete 80 hours at a clinical site in the last semester \(Placement at a San Antonio or surrounding area facility during daytime business hours is required. Save Paid Time Off, Vacation Time, and/or Leave Time starting now.\) Online courses are rigorous and reading intensive, as is the profession.](#)

All students accepted into Health Information Technology program at St. Philip’s College must present evidence of having met the immunization, CPR AHA-BLS, Criminal Background Check and Drug Screen requirements which are due the first Friday in December. Further detail about the program will be given to students in the HITT Student Handbook, during the first day of the semester meeting.

THECB statutory requirement. Notice to All applicants and enrolled students:

For Health Information Technology, the program is not licensed or certified, but offers a registry exam (Registered Health Information Technician) upon successful completion of the program, at American Health Information Management Association <https://ahima.org/> by the Commission on Accreditation for Health Informatics and Health Information Management, available at <http://www.cahiim.org/index.html>

Program Physical and Mental Requirements. In order to fulfill the requirements of the Health Information Technology program, students must be able to meet the physical and mental demands associated with the profession. These requirements include but are not limited to the following: standing, sitting, lifting, talking, seeing, communicating, etc. Time is spent sitting for entering and analyzing data. Electronic data entry is frequently required as sitting in front of the computer for several hours. Emotional maturity and stability to approach highly stressful human situations in a calm and rational manner. Using clinical judgement for critical thinking, adhere to ethical standards of conduct. Ability to provide effective written, oral, verbal and nonverbal communication.
