In keeping with the Southern Association of Colleges and Schools' Principles of Accreditation: Foundations for Quality Enhancement, St. Philip's College would like to notify you of a substantive change to be implemented fall 2022. The change relates to Substantive Change Procedure Three for closing a site.

In fall 2022, St. Gerard Catholic High School, located at 521 South New Braunfels Avenue, San Antonio, TX 78203, ceased offering any courses. The school had very low enrollment and also met financial issues in sustaining operations of the school. The Archdiocese of San Antonio opted to close the school completely since enough funds could not be raised to keep it open. Summer 2022 was the last term their students were enrolled in college courses.

The Dual Credit students were taking academic courses, not in a designated program of courses, and courses towards the Web and Mobile Developer Level 1 Certificate. Per semester, St. Gerard Catholic High School (10-15) students would sign-up for a selection of online or St. Philip's College campus courses: ENGL 1301, 1302, 2322, 2332; ARTS 1301, 2316; HIST 1301, 1302; GOVT 2305, 2306; CRIJ 1301; ECON 2301; PSYC 2301; SOCI 1301; SPCH 1311; SPAN 1411, 1412. The students working towards the Web and Mobile Developer Level 1 Certificate took courses for that degree: ARTC 1301; IMED 1301, 1316, 2315. The students transferred to different area high schools, and/or local home/private/charter schools. Faculty teaching the online and St. Philip's College campus courses were St. Philip's College employees.

The teach-out plan is attached.

Teach-out Plan

St. Gerard Catholic High School – Associate of Arts

A teach-out plan is a written plan developed by an institution that provides for the equitable treatment of students if an institution, or an institutional location that provides fifty percent or more of at least one program, ceases to operate before all students have completed their program of study, and may include, if required by the institution's accrediting agency, a teach-out agreement between institutions. Teach-out plans must be approved by SACSCOC in advance of implementation.

To be approved, a teach-out plan must include the following information:

1. **Date of closure** (date when new students will no longer be admitted)

On July 15, 2022, Archdiocese of San Antonio made the difficult decision to close St. Gerard Catholic High School, prior to the 2022-2023 academic year, after 95 years. Archdiocese was faced with the challenging reality of very low enrollment and concerns over having enough financial support to sustain operations of the school. Summer 2022, St. Gerard Catholic High School had their last set of students go through SPC Dual Credit program. Fall 2022, there will be no students in St. Philip's College's Associate of Arts and Web and Mobile Developer Level 1 Certificate program. The high school has closed its location at 521 S. New Braunfels, San Antonio, Texas 78203.

2. An explanation of how affected parties (students, faculty, staff) will be informed of the impending closure.

Parents and students were informed by the Archdiocese of San Antonio through letters, meetings, and social media.

3. An explanation of how all affected students will be helped to complete their programs of study with minimal disruption.

The Department of Catholic Schools and the Archdiocese of San Antonio are committed to assisting current families in their transition to another Catholic High School if they so desire. The students can continue taking the Dual Credit courses offered at other public/private/charter/home schools.

4. An indication as to whether the teach-out plan will incur additional charges/expenses to the students and, if so, how the students will be notified.

No cost to Dual Credit students.

5. Copies of signed teach-out agreements with other institutions, if any.

There is not a signed teach-out agreement for the courses with St. Gerard Catholic High School. Not applicable.

6. How faculty and staff will be redeployed or helped to find new employment.

All instructors were St. Philip's College instructors and are still employed by the college. The school staff at St. Gerard Catholic High School were either moved to a different Catholic High School or found positions elsewhere.

7. If closing an institution, arrangement for the storing of student records, disposition of final financial resources and other assets.

St. Philip's College is still an operational institution as of October 6, 2022. The Archdiocese of San Antonio will maintain all relevant records for St. Gerard Catholic High School.
