Thank you for your letter of October 15, 2010, transmitting a prospectus for the Associate of Applied Science degree program in Electronics Technology to be offered, effective January 2011.

The program is being transferred from San Antonio College. Students enrolled in this program will be able to earn the A.A.S. in Communications Electronics Specialty, Computer Electronics Specialty, or Industrial Electronics Specialty. In addition, the College will offer a Level I Certificate in Electronics Technology, a Local Certificate in Digital Fundamentals, and three Marketable Skills Certificates: Basic DC/AC, Basic Electronics, and Basic Semiconductor.

The program has been approved by the College curriculum committee and the curriculum committee for the District and will be administered by the Chair of the Electronics and Information Technology Department. Twelve new courses were developed. The curriculum for each of the programs (A.A.S., Certificate, Marketable Skills Award) was included. Learning resources, physical resources, and financial resources are in place to support the program. Evaluation and assessment processes were described. The faculty roster documented appropriate qualifications for faculty members teaching in the program.

We approve the A.A.S. degree program in Electronics Technology, the certificate programs, and the marketable skills awards and request no further information.

Enclosed is an invoice for \$300 to help defray the cost of reviewing the prospectus.
