The Board of Trustees found that the Competitive Sealed Proposal (CSP) procurement method is most appropriate to this project and awards a contract providing for the purchase of Construction Services for Renovation of the Eastside Education & Training Center for the Alamo Colleges District to Tejas Premier Building Contractor, Inc. for the amount of \$1,120,555, as requested by the Interim Vice Chancellor for Economic and Workforce Development, subject to contract terms acceptable to District Counsel.

Discussion and Possible Action on Guaranteed Maximum Price for Alamo Colleges District – Southside Education and Training Center Capital Improvement Project (CIP), Construction Manager-at-Risk Contract with Thomas S. Byrne dba Byrne Construction Services (CSP 18C-005), Lacy Hampton

The Board of Trustees approved the Guaranteed Maximum Price Construction Manager-at-Risk fee negotiated with Thomas S. Byrne dba Byrne Construction Services in the amount of \$15,759,604 (including contingency) for the construction of the Alamo Colleges District – Southside Education and Training Center Capital Improvement Project (CIP), subject to subsequent execution of GMP amendment acceptable to District Counsel by Chancellor or delegate.
