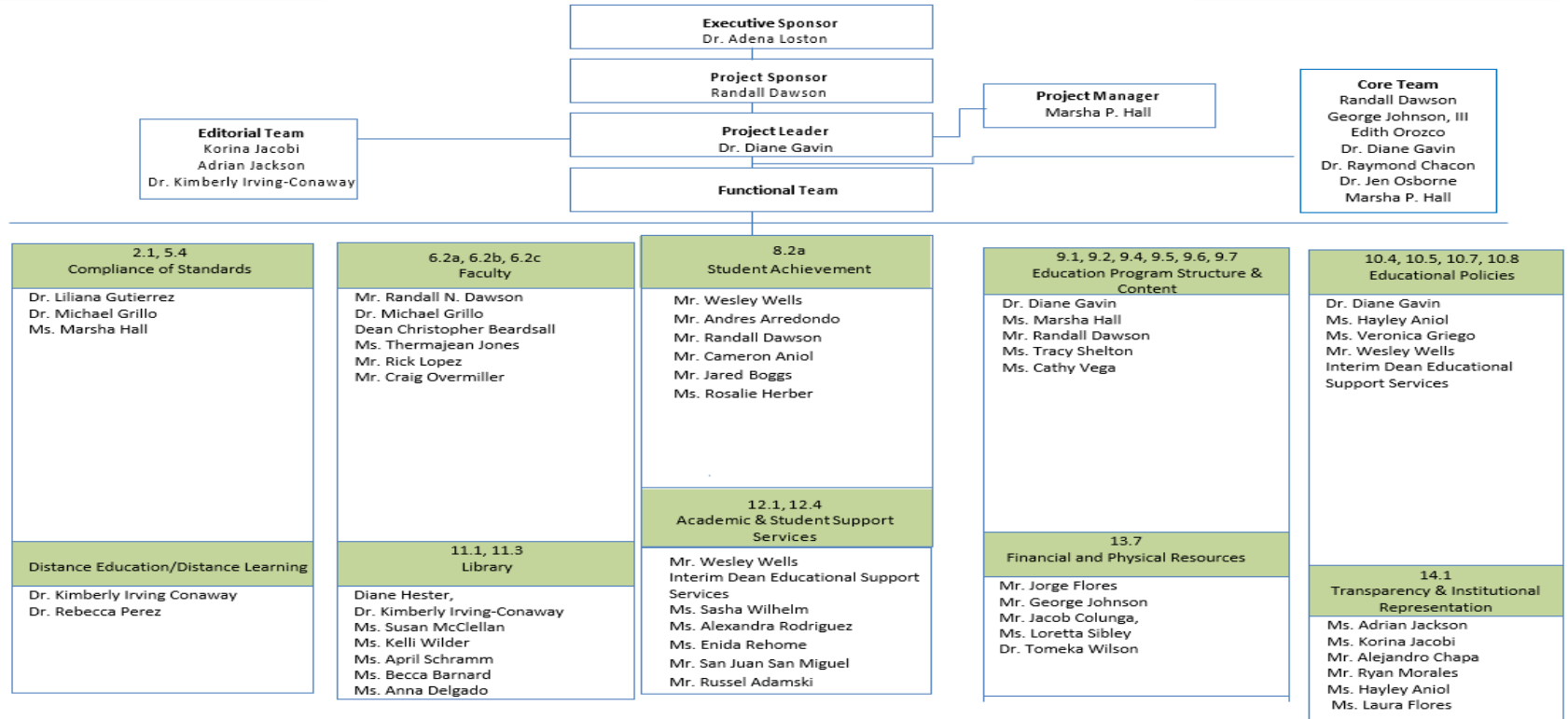

All programs included in the institution's application must meet the relevant standards and be approved by the SACSCOC Board of Trustees for the institution to be accredited at the new level.</p> <p>As part of the approval process, the SACSCOC Board of Trustees will authorize a Substantive Change Committee to conduct a visit no more than six months following the initiation of the new program(s). In accordance with the SACSCOC's Substantive Change Policy and Procedures, all applications for accreditation at a higher or lower level will be reviewed by the SACSCOC Board of Trustees at either its June or December meeting.</p>

Student Numbers

- **75** students per semester for first year; **100** per semester in subsequent years = Enrollment Projections

- **\$64,293** = Average annual starting salary in San Antonio for Proposed BAT Cybersecurity grads (*BLS*)
