# **PRINCIPLE-CENTERED LEADERSHIP – GOAL 1, OBJECTIVE 1.1**: Develop strategies and systems that promote leadership development.

Measure: Conduct landscape analysis and report back.

Report: Landscape analysis conducted: ALAS, Emerging Leaders, Staff Senate, Faculty Senate, and committees are the list.

Decision: Vote – Met the measure and it will be retired. No opposition.

**PRINCIPLE-CENTERED LEADERSHIP – GOAL 1, OBJECTIVE 1.2**: Develop strategies and systems that promote accountability.

Action Plan: Initiate and support nominations for staff and faculty to participate in accountability development.

Decision: Will not close this out; will come back, with some strategies for implementation.
